



## Dr. Clara Ann Mason, DVM

September 30, 1960 - March 5, 2026

Dr. Clara Ann Mason, DVM, passed away peacefully on March 5, 2026, at University of Maryland Shore Medical Center in Chestertown, Maryland, following an extended illness. She was 65 years old.

Born on September 30, 1960, in Baltimore City, Maryland, Clara Ann moved in 1964 to her father's ancestral home in Easton, where she grew up and attended Talbot County Public Schools. A 1978 graduate of Easton High School, she excelled academically as a member of the National Honor Society and proudly played in the band.

She earned a Bachelor of Science degree in Animal Science from the University of Maryland, College Park, where she was an enthusiastic member of the Maryland Terrapin Marching Band and Delta Gamma sorority. Clara Ann then received her Doctorate in Veterinary Medicine from Mississippi State University.

She dedicated her 40-year career to large animal mobile veterinary practice, specializing in equine medicine across West Virginia, Ohio, and Kentucky. A respected expert in her field, she co-authored numerous textbook chapters on equine medicine, presented frequently at professional conferences, served as a consultant on equine animal welfare, and maintained a close professional relationship with The Ohio State University College of Veterinary Medicine.

Clara Ann was predeceased by her parents, Frank E. Mason Jr. and Mary S. Mason; her grandparents, Dr. Frank E. Mason and Edna M. Mason, and Carmine Serrano and Maria Serrano.

She is survived by her brothers, Frank E. Mason III and Matthew S. Mason (and his wife, Kerry); three nieces, Bonnie, Catherine, and Caroline; two great-nephews, Mason and Bennett; and one great-niece, Francesca.

A lifelong member of Christ Episcopal Church in Easton, where she was baptized as an infant, Clara Ann's services will be private.

“ *In Memory of Dr. Clara Ann Mason: A Life of Courage, Compassion, and Unwavering Advocacy for Animals — Dr. Rustin M. Moore*

*As I was putting the finishing touches on Restoring the Bond, a message arrived that stopped me in place. On March 5, 2026, my dear friend and colleague, Dr. Clara Ann Mason, passed away after a lengthy illness. Clara devoted her life to defending animals who could not defend themselves and reminding the world that compassion must be stronger than neglect.*

*I first met Clara in January 2009 at the American Association of Equine Practitioners Winter Resort Meeting on Australia’s Gold Coast. She was traveling with her classmate and close friend Leslie. What began as a chance introduction soon became a lasting friendship.*

*Over the years she visited James and me whenever her travels brought her through Ohio or West Virginia. When she treated horses near Spencer, she often stopped to check on my father—always texting first: “Is it okay if I stop by and see your pops on my way out of town?”*

*One summer she joined us at my parents’ home for a shrimp and crab boil that James prepared, laughing easily among neighbors who already knew her through the horses she cared for. In those small Appalachian circles, Clara felt immediately at home. She was never simply a guest—she became part of our extended family.*

*Although Clara had an entire circle of people—family, clients, colleagues, and more—who adored her, including her best friend, Leslie, I suspect she might have referred to Drs. Harry Werner, Bill Moyer, and me as her own version of the Three Musketeers—friends she trusted to stand beside her, speak honestly, and defend her and the animals she loved.*

*When my mother passed away in 2019, Clara attended the Celebration of Life without announcement or expectation of recognition. That quiet gesture revealed the heart she carried into every relationship.*

*Clara trusted the Ohio State Veterinary Medical Center deeply, bringing her own horses and dogs for care and referring her clients and patients to us for advanced diagnostics or treatment.*

*Clara endured hardships few could imagine. While still in veterinary school, Clara was diagnosed with ovarian cancer that had spread throughout her abdomen. She faced the diagnosis with remarkable resolve and continued forward with the determination that defined her life. Later, she survived domestic violence and rebuilt her life with quiet strength.*

*Another challenge followed when a bite from a Lone Star tick triggered alpha-gal*

*syndrome, leaving painful wounds on both legs that never fully healed. Physicians across several medical centers searched for answers, but little eased her suffering. Clara knew what it felt like when the systems meant to help people falter at the moments they are needed most.*

*Even so, she carried forward with the same determination she had always shown for animals who depended on her. Nearly everyone who knew Clara admired and cared deeply for her, yet there were moments when the support she deserved did not fully arrive—something she endured with the same quiet strength that defined her life.*

*Through it all, Clara never stopped fighting for animals who had no voice. Clara became nationally respected for confronting equine neglect and abuse. Investigators, prosecutors, and veterinarians sought her expertise because she brought both scientific precision and moral clarity to difficult cases. When horses suffered, Clara refused to look away.*

*Clara understood that cruelty fractures the fragile trust between people and animals, and she devoted her life to repairing that fracture wherever it appeared.*

*Her courage was perhaps best reflected in the case of a filly named Sansa, who survived severe neglect and cruelty because Clara refused to surrender her life. Clara documented the injuries with clinical precision, testified without hesitation, and pursued justice—not only for that horse, but for every animal who might suffer the same fate.*

*In 2019, the American Association of Equine Practitioners Foundation honored Clara with the Good Works for Horses Award for advancing equine welfare and strengthening animal-cruelty laws in West Virginia. I had the privilege of standing beside her at the AAEP Annual Convention when she received that recognition.*

*True to her character, Clara accepted the award with humility—and unbeknownst to me until that moment, quietly donated the monetary award, even matching it, to the Roane County Shelter in my hometown of Spencer, West Virginia.*

*Clara grew up in Easton, Maryland, where riding hunter-jumper horses first sparked the passion that would guide her life. She studied Animal Science at the University of Maryland, pursued graduate work at Johns Hopkins University, and earned her Doctor of Veterinary Medicine from Mississippi State University in 1992. She later practiced in West Virginia with skill, compassion, and unwavering dedication.*

*Animals sensed her kindness instinctively—often before people did. Horses that arrived tense and trembling often softened under her hands, lowering their heads as if they recognized something rare: a human who had come only to help. Dogs leaned quietly against her legs as if they had known her forever.*

*Her home in Winfield reflected that same heart. She shared it with her dogs—Paisley and later Avery—three horses, a rescue cat named Fiona, and a rescued parrot named Louie who had been with her since veterinary school.*

*They were there for a simple reason: Clara believed every animal deserved dignity, safety, and love—and she made sure they received it. Her commitment was more than a belief; it was a way of living. Each day, through the choices she made and the courage she showed in difficult moments, Clara embodied the very bond she worked to restore between people and the animals who depend on them.*

*Clara's life reminds us that restoring the bond is not an abstract idea—it is lived through courage, sacrifice, and the refusal to ignore suffering when others look away. My life was richer for having Clara Ann Mason in it.*

*Clara believed the work of a veterinarian extended far beyond treatment rooms and barn aisles. It meant standing beside the vulnerable and refusing to accept suffering as inevitable. Though her voice is now quiet, her legacy continues—in every veterinarian who refuses to look away, and in every life made safer because Clara Ann Mason once stood in its defense.*

*Now, at last, she has found the peace—and freedom from pain—that eluded her for so long.*

*The animals whose lives she protected will carry her legacy forward.*

*Rest well, my dear friend. You earned it.*

*Clara Ann Mason will never be forgotten. Her courage, her compassion, and her unwavering defense of animals will continue to guide those who believe that protecting the vulnerable is among the highest callings of our profession—and our humanity.*

*And I will do everything I can to honor Clara's memory and the creatures she spent her life protecting.*
