Laura J. Redifer Dick of Easton, MD, died June 20, 2018, at the Eleanor A. Koons Hospice House in Easton. After a long battle with emphysema, she is now at peace.

Born in Easton on October 14, 1950, she attended elementary school there before moving to Las Cruces, NM. After graduating from high school, she spent a year in Sunnyvale, CA, before returning to the Eastern Shore.

Laura was employed as a Court Administrator for the Second Judicial Circuit of Maryland. She was highly respected and enjoyed working with the Honorable William S. Horne. After being with the Circuit Court for 17 years, she retired in 2009. She enjoyed her time there and spoke fondly of her coworkers.

She was married to the love of her life, Perry C. Dick, III. In July, they would have been married for 33 years. Before moving to Easton, they lived on a farm in Tunis Mills, MD, raising goats, chickens, dogs, and two daughters. They loved to take their camper to the Assateague National Seashore to surf, fish, and explore. After Laura retired, they trekked West to visit the meaningful places of her youth.

Laura had a creative soul and enjoyed drawing, painting, making stained

glass and pottery. In her later years, she discovered the joy of mosaics with Jen Wagner-Campbell. Her art hangs proudly in her family's homes. Laura also was passionate about animals. She visited Best Friends Animal Sanctuary in Kanab, UT, on more than one occasion. All her animals were rescued from local shelters, but she had a special love for Talbot Humane.

Laura was predeceased by her mother, Jane Walker Redifer; her father, Earl F. Redifer; and her granddaughter, Halley A. Lambert.

She is survived by her loving husband, Perry C. Dick, III, of Easton; two daughters, Christie Woodard (David) of Easton and Becky Mann (Dave) of Denton, MD; her grandchildren, Colin Woodard of Easton and Alexandra Woodard and her fiancé, Sean O'Connor of Trappe; and a great granddaughter, Sophia Mae O'Connor.
