



## Nicholas Vincent Arena

October 10, 1989 - August 1, 2013

Nick (Nicholas Vincent) Arena died on August 1, 2013, in Tolchester, MD, at 23 years old.

Nick lived with his father and stepmother, Chip and Rachel Arena, in Tolchester, and his mother, Janet Higgins, lives in Wilmington, DE.

Nick died in a single car, fatal crash on the road from Tolchester to Rock Hall at 7 p.m., Thursday, August 1, 2013.

Having graduated at the top of his class at Valley Forge Military Academy as the Commander of the Corps of Cadets, and second in his class academically, Nick went on to Montreal, Quebec, to found a business with a Valley Forge classmate. Nick then attended Rutgers University and went on to found another business in Newport, RI.

Nick moved back to the Eastern Shore in 2012 and worked at Angelica Nurseries and at Chester River Landscaping, where he was recently promoted to crew chief and supervisor.

He loved the Bay and everything about the outdoors. He loved doing anything with his family, and as a family.

Nick was a very, very hardworking, self-motivated young man who always had a "project" at home in addition to the long hours that he put in at his job. He touched everyone who knew him with his broad, winning smile and with his ability to talk engagingly to anyone—of all ages.

He is survived by his brother, Rocco, 25, who lives in Los Angeles, and his parents.

In lieu of flowers, Nick's friends are invited to contribute to the Chesapeake Bay Foundation or the Nature Conservancy, in his name.

There will be a Celebration of Nick's Life at his home at Baymeadow, 8713 Park Drive, Chestertown, Maryland 21620, on Saturday, August 17, starting at 2 p.m. and ending with a sunset celebration—an event that Nick in some way celebrated each evening.

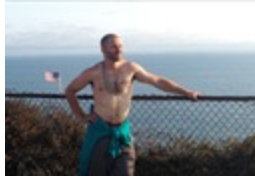

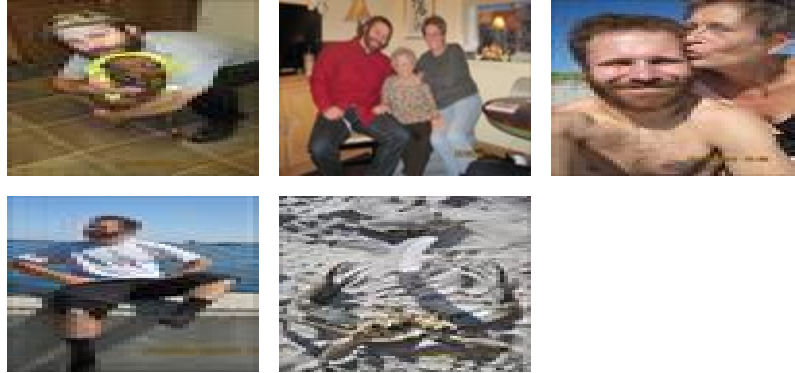

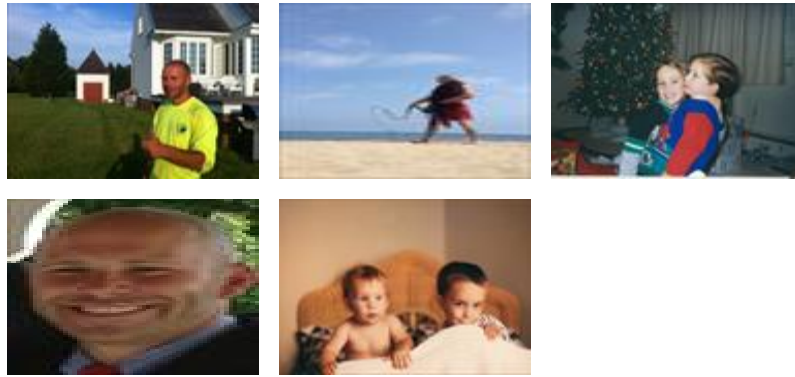
